# Incentives

Funding decisions are based on a number of project factors, including but not limited to job creation, additional payroll, fixed-asset investment commitment, project return on investment and project location. ## **JOBSONIO ECONOMIC DEVELOPMENT GRANT**

Promotes economic development, business expansion and job creation by providing funding for eligible projects in the state of Ohio.

## **JOBSONIO GROWTH FUND**

Provides capital for expansion projects to companies that have limited access to funding from conventional and private sources of financing.

## **JOBSONIO RESEARCH AND DEVELOPMENT CENTER GRANT**

Facilitates the creation of corporate R&D centers in Ohio to support the development and commercialization of emerging technologies and products.

## **JOBSONIO REVITALIZATION PROGRAM**

Focuses on helping rejuvenate sites in preparation for end users that support job creation opportunities for Ohioans.

## **JOBSONIO WORKFORCE GRANT**

Promotes economic development, business expansion and job creation by providing funding to companies for employee development and training programs.

## **OHIO JOB CREATION TAX CREDITS**

Offers state refundable tax credit applied toward a company's Ohio Commercial Activity Tax (CAT) liability.

## **TALENT SERVICES**

Assistance finding a skilled, trained workforce through talent attraction, sourcing and pre-screening as well as through customized training programs.

## **JOBSONIO INCLUSION GRANT**

Provides financial support for projects in distressed communities and/or for businesses owned by underrepresented populations across the state.
